- 4. SB County 3<sup>rd</sup> District Supervisor Dawn Rowe says:
  - On June 30, 2021, Code Enforcement mailed 455 notices to un-permitted vacation rental hosts notifying them that they have 30 days to submit an application for a Short-Term Rental permit.
  - If any of these hosts fail to comply with this demand they will be subject to the new \$1,000 per day fine the Board of Supervisors recently adopted in an emergency ordinance.
  - Code Enforcement is utilizing Rentalscape software to scour hosting platforms and identify un-permitted properties.
  - Code Enforcement also created a web page to assist the public in identifying up-permitted properties. The web page uses a map to show each permitted STR and if someone finds out that a property isn't permitted, it provides information on how to report it to Code Enforcement.
